5 Years Manufacturer Warranty Conditions

Limited Warranty

This Limited Warranty applies to the lithium batteries, including all the LiFePO4 ("product") provided by Perfektium. The warranty period begins from the date of invoice. The warranty period will not start again, especially in the case of replacement or repair.

1. What does this Limited Warranty cover?

This Limited Warranty covers any defect in material and workmanship under normal use during the Warranty Period. This Limited Warranty is to the original purchaser of the products and is not transferable to any other person or entity. Within the Warranty Period, Perfektium will repair or replace the products or parts of the product that are determined to be defective in material or workmanship under normal use and maintenance. To purchase a suitable lithium battery, the distributor or user must provide the battery model and quantity.

2. What will we do to correct problems?

Perfektium will either repair or replace the product or parts of the product with no charge, by using new product or parts.

3. Warranty Period

According to the characteristics of lithium batteries, Perfektium batteries are warranted to the original purchaser or subsequent owner from the date of invoice for 72 Months (6 years) for Lithium batteries.

4. Additional Warranty Policy

After Warranty Period, for any failure, if the product is reasonable to repairable as determined by us, it will be repaired at basic material cost and returned to you, and freight at your side. If it is not deemed repairable by Perfektium, Perfektium will offer you a new, similar replacement battery at 10% discount of the concurrent price listed on the latest price list of Perfektium.

5. Warranty Disclaimer

Perfektium makes no representations or warranties regarding the product other than those expressly stated in this Limited Warranty. To the fullest extent that damages may be disclaimed by law, Perfektium shall not be liable, whether in contract or tort (including negligence and strict liability), for any damages in excess of the product's purchase price or for any indirect, incidental, special, or consequential damages of any kind, or any loss of revenue, profits, business, information, data, or any other financial loss arising out of or in connection with the user inability to use the product.

6. What does this Limited Warranty not cover?

Years Warranty

a. Each of the product has a built-in battery management system (BMS) designed to cut off power to prevent damage to the cells or electronics if it senses any of the following conditions: Over-charge or over-discharge, over voltage, under voltage, over current while charging or discharging and under or over temperature.Damage caused by repetitive BMS protection cycling is considered abuse and is not covered.

b. This Limited Warranty does not cover products failure related to damages caused by abuse or negligence, tampering, non-adherence to Perfektium guidelines or from any of the following: Damage from shipping, corroded hardware, failure to properly install and connect the battery, Failure to properly charge and maintain the battery, Breakage or damage from collision, fire, freezing, damage from extreme heat or cold, improper storage, reverse polarity connection, short circuit of the battery terminals or water damage.

c. This Limited Warranty does not cover repair, maintenance, and adjustment to the product required for reasons of neglect, misuse, accident, modification without Perfektium's prior written approval, improper environment (including lack of proper temperature or humidity), unusual physical or electrical stress or interference, failure of lightning, fire, or natural disaster.
d. This Limited Warranty does not cover normally worn out batteries. It is possible to use up the battery life prior to the end of Warranty Period by using the LiFePO4 battery over 4000 cycles.

7. Legal Rights

Some countries and/or states do not allow limitation on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages, so the above limitations may not apply to you. This warranty gives you specific legal rights, which may vary from country to country and/or state to state. This warranty is understood to be the exclusive agreement between the parties relating to the subject matter hereof. No employee or representative of Perfektium is authorized to make any warranty in addition to those made in this agreement.
